This Month's Program: May 18, 2006 - 7pm Conservation in the Green Swamp by Marian & John Ryan

The Green Swamp is one of the largest swamps in the United States but is more a poorly drained plateau than a "swamp" as we usually imagine it. It is considered the largest natural habitat core in Central Florida, with a vast array of wildlife. It also provides important water recharge to the Floridan Aquifer, and in 1974, the Florida Legislature designated approximately 187,000 acres in Lake and Polk Counties as an Area of Critical State Concern. Marian Ryan, Green Swamp issues chair for the Florida chapter of the Sierra Club, is working with legislators and local governments to continue conservation land acquisition in the swamp, incredibly difficult in this climate of land speculation. Marian with her husband John will inform us about the Green Swamp, update us on these efforts, and let us know what we can do to help. Join us May 18 for an interesting and informative program.

Econ River Faces New Threats

The Econlockahatchee River in southeast Orange County is facing new threats from development proposals being promoted in conjunction with the Innovation Way plan. Orange County has amended their Comprehensive Policy Plan to provide for development in the southeast area of the county between the airport/Lake Nona area and the Econ River. This plan amendment has been sent back from the State with various findings of deficiencies and inadequacies. The idea of Innovation Way, with its specific development criteria and other elements, was originally confined to a corridor area that would be several miles wide along an extension of Alfaya Trail south of the Beachline Expressway, then routed west to the

Narcoosee Road area.

Orange County has now revised their proposed Plan amendment and it will be heard by the Orange County Commissioners on May 23rd. The revised plan, as it now reads, will be that part of southeast Orange County between SR417, east to the Econ River, south of the Beachline to the Osceola County line as the Innovation Way Study Area Overlay. In the revised plan, new development within the Study Area Overlay will be allowed if it supports and furthers a Compact Village Conceptual Urban Form Scenario that is also detailed in the amendment. The original Innovation Way Corridor Village plan appears to now be able to be placed anywhere within the 32,000 acre Study Area Overlay. Any new development will have to go through a plan amendment process as this overlay district will not change any of the existing land use designations currently in existence.

Language from the existing Econ River Protection Ordinance has been incorporated into this new amendment as it regards possible crossings of the river. Preservation of environmentally sensitive lands will be necessary, but how that will be accomplished is not well defined. Only species that are listed as Threatened or Endangered would be a trigger for habitat preservation.

At the Planning and Zoning Commission meeting on April 20th, Audubon member Marge Holt and I spoke of our concerns with the revised amendment. The revision

seems to open up the entire I-W Study Area to the possibility of new development in the Village Urban Form Scenario. I spoke on several issues; that the revised plan could cause unending sprawl in this area, with the possibility of tens of thousands of residential units being built, not tied to job creation, or square feet of built commercial/office space. The preservation of listed species must include species of special concern, as these species reside in critical habitat in the Study Area. Preservation of sensitive habitats must be better defined and the mechanisms for doing so need to be identified.

You can read this revised amendment on the Orange County website: www.orangecountyfl.net. It is Future Land Use Element Amendment #2006-1-B-FLUE-2 (Innovation Way).

This plan allows for building of thousands of residential units, with large amounts of commercial/retail building in this area, with no defining criteria for need or actually tied to the creation of high tech jobs that are necessary to expand Orange County's economic base. Sprawling overdevelopment impacting one of our last sensitive riverine habitats is not necessary to accomplish building a high-tech corridor from the new UCF Medical School campus to the main UCF Campus. If you are concerned about the impacts of the I-W amendment, please tell your County Commissioner, and attend the public hearing on the amendment at the May 23rd BCC meeting.

2006 Ft. DeSoto Field Trip Report Another Great Day of Birding!

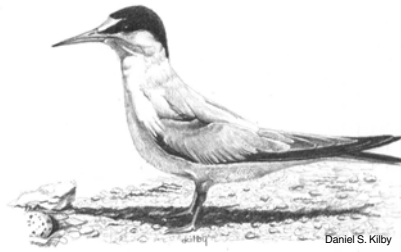
On April 8, 2006, 25 members of the Orange Audubon Society participated in the annual field trip to this marvelous park in Pinellas County. Although the migrants did not show up as desired, we had a wonderful day because of the tremendous numbers of shorebirds and seabirds and a little bit of dumb luck. Sometimes it is better to be lucky than good. Altogether, we had 63 species including the following: Magnificent Frigatebird, Reddish Egret, Roseate Spoonbill, Northern Shoveler, Redhead, Lesser Scaup, Bald Eagle, Cooper's Hawk and Sandhill Crane. Shorebirds included Black-bellied Plover, Semi-palmated Plover, Killdeer, American Oystercatcher, Willet, Whimbrel, Marbled Godwit, Least Sandpiper and Dunlin. We had five (5) tern species; Royal, Sandwich, Common, Forster's and Least, along with Black Skimmer.

The "birds of the day" were the ten (10) Yellow-crowned Night Herons and five (5) nests in the rookery that we found in the East Beach Woods. They just sat there and

watched us as we stood in awe and watched them. What a sight! Their yellow crowns were so vivid that they looked like neon! This was just a spectacular sight! The Black-hooded Parakeets put on a show for us most of the day; chasing each other around and screaming in that loud call that they have.

So, even though we did not get to see a lot of migrants as we had hoped for, it turned out to be a wonderful day of birding with good birding friends.

Local Rehabber in Need of Help

Mrs. Ann Young, the Director of the Ann Young Wild Bird Refuge is in need of caring adults to care for orphaned, wild baby birds. Caring for wild birds is a unique experience and one which is not offered by most cities. The refuge is a non profit shelter aimed at rescuing injured and orphaned wild birds. It is located in Ann's home. Each year, Ann (Licensed by the state and federal governments), rehabilitates and releases hundreds of wild birds brought to the refuge by caring people. Ann has nurtured birds for 25 years. She works very diligently, at times around-the-clock, assisted by a small team of volunteers. Her work has become vital to these fragile creatures whose survival is being threatened. The refuge is in need of help, especially now in the spring and summer since birthing season usually occurs between March and the end of August. Please consider donating some of your time or money to this worthy cause.

*The refuge needs quiet, bird loving volunteers to work at least 2 hours, one time per week to feed baby birds. (nestlings need to be fed every 1/2 hour)

*Scheduling: Volunteers are asked to go by the refuge and sign up for a time slot. Be prepared to volunteer at this time, as this is the height of the birthing season and Ann may need you then. Please do not phone the refuge as Ann does not have time to answer the phone.

*Snacks: Please bring your own snacks. (Ann runs the refuge on donations and does not have a car.)

*DIRECTIONS: Ann's home is located at 205 Robin Road, Altamonte Springs 32701

It is off of Hwy 436, between Hwy 17-92 and the Railroad Tracks.

Specific directions from Hwy 17-92:

Go West on Hwy 436

Go through 2 stoplights (passing Circuit City on Left)

Left at Robin Road (at Calico Corner Fabrics)

Ann's home is behind a stone wall on the left at the bend.
