BIRDATHON 2009 - 187 Species!

The first phase of **BIRDATHON 2009**, is **complete!** On April 11th our skillful and enthusiastic birders located **187 species!** It's now time for that all-important second phase. It's time for all of you to contact your sponsors and gather your pledges. If you got a \$.10 per species pledge, for example, you will need to get a contribution of \$18.70. Multiply other pledge amounts by 187 accordingly. You will also need to get the name, address, phone and/or email for each sponsor as Birdathon contributions are tax deductible. At 187 species, we were forty more than last year! Lake County Park Ranger and new board member Gallus Quigley saw the most birds with 108 species (including a Mississippi Kite!) followed by my team with 82. In all more than 50 birders participated! Now, gather your pledges! Thank you all for what's shaping up to be a very successful event.

Scat, Tracks, and Bones by Gregg Thompson

As usual, LE-FTs are limited to ten people and reservations are required. There is also a fee of \$10.00 dollars for members, \$15.00 for non-members. Reservations will be taken beginning May 16th.

The LE-FT of April 11th (also Birdathon Day) to the Canoe Creek Road Area of Osceola County

concentrating on the Three Lakes Wildlife Management Area and Joe Overstreet Road, was very successful yielding 82 species of birds including: White-tailed Kite, Swallow-tailed Kite, Snail Kite, many Bald Eagles, Crested Caracara, Peregrine Falcon, Purple Gallinule, Limpkin, Solitary Sandpiper, Burrowing Owl, Red-cockaded Woodpecker, Brown-headed Nuthatch, Eastern Bluebird, and Bachman's Sparrow. Many alligators, some quite large, were seen at Lake Jackson inside Three Lakes WMA. An Eastern Diamondback Rattlesnake was also seen and photographed. Whoo Hoo!

Dress casual, it's a little jungle complete with things that bite, sting, stick and scratch. No access to restrooms on the Preserve. 4 hrs walking through 48+ acres. Bring birding gear, waters, snacks and your best birding etiquette so we may be invited back!

April Field Trip Report

Fourteen birders attended the OAS field trip to Seminole State Forest on April 18th. The group observed at least 43 bird species including Roseate Spoonbill, Wood Stork, Am. Swallow-tailed Kite, Red-tailed Hawk, Common Ground-Dove, Chimney Swift, White-eyed Vireo, Florida Scrub-Jay, Barn Swallow, Brown-headed Nuthatch, Marsh Wren, Eastern Bluebird, Black-and-white Warbler, Common Yellowthroat, Eastern Towhee, and Swamp Sparrow. The group enjoyed looking at animal tracks on the sand road including those of the millipede, Gopher Tortoise, Wild Turkey, and lizard (possibly Six-lined Racerunner).

Flowers in bloom included Crow Poison, Pawpaw, St. Peter's Wort, Shiny Lyonia, Rusty Lyonia, Deerberry, Blackberry, and Pennyroyal. While the map-reading talents of the leader (Mary, I think her name was) left something to be desired, the group got back safely and in good humor. When we got back, a "Welcome to the Woods" event put on by the Florida Fish and Wildlife Conservation Commission (FWC) was in full swing. There was a wildlife display, bear cage, FWC helicopter, information about the importance of fire, hay rides, fishing demonstrations and more.

Silent Auction

The June 18th Orange Audubon Society (OAS) meeting will once again include a Silent Auction with items from local businesses and items that you have personally made, baked or grown (Make It, Bake It, Grow It- i.e. MIBIGI). Please notify us ahead of time of your planned contribution so that the volunteers organizing this event will also be able to enjoy the evening; last minute contributions 'without notification' can frazzle the most disciplined volunteer.

If you 'know' a business owner who might contribute to the Silent Auction, please solicit a donation or provide us with the contact person. If you have something to contribute to June's MIBIGI, please contact me (407/886-2925; LNS-OAS@att.net) so that time and space may be allotted and bid sheets may be made prior to the meeting. For all donations, please describe the item(s), and suggest a minimum bid price and an approximate retail price (to ensure proper sales tax treatment and maximum fund raising potential). **Deadline for notification is Sunday, June 14th** since the meeting is June 18th.

Judging from experience, two or three lower priced contributions will probably receive more bids than a larger, more expensive item (e.g. if you bake cookies, package them into 3 or 4 cookies per item with a fair minimum price rather than putting 12 cookies in one package at 3 times the minimum price). We can discuss your options when you contact me.

Unfortunately we cannot accept 'gently used' items for this auction due to space and time constraints. We will try to have an evening for your 'gently used', nature-oriented items next fall, combined with an evening of OAS merchandise sales. Whether we have this event or not will be determined during our summer planning sessions; if we do proceed with it, it will be prior to the holidays so you may do your shopping with OAS.

Since the June dinner/auction/program is a busy, jam-packed evening, we need several volunteers to help us throughout the silent auction (it's not hard work, just a lot of it in a few hours — checking items in, keeping bid sheets current and items organized during the auction, and upon close of the auction, 'running' items to the cashiers for payment and check out). 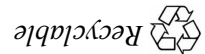

OAS Participates in NAS Southeast Region Election

On April 16th, the Board of Directors of Orange Audubon Society (OAS) unanimously voted our three ballots for the Interim Director for National Audubon Society’s Southeast Region (AL, FL, GA, LA, MS) for S. Joyce King. Several OAS board members know Joyce and thought she was the best of the three candidates on the ballot. She is a longtime member and past president of St. Petersburg Audubon Society and has recently moved to rural north Florida, where they are developing a new Audubon chapter (Santa Fe Audubon). FYI, the number of ballots a chapter was allocated was based on a chapter size formula. Since OAS has 1,544 members, only two chapters in the region had more members and more ballots (A.S. of the Everglades and Atlanta A.S.).
