This Month's Program: March 20, 2003 - 7pm Eight Years of Wekiva Bird Banding by Richard Poole, Ph.D.

For eight years, Richard Poole has been getting up before dawn and driving to Rock Springs Run State Reserve or Wekiwa Springs State Park to set up mist-nets to catch birds for banding. With his wife Christine, Bob Wheeler, and many other volunteers, Richard carries on what is currently the longest running bird banding station in Florida. A key feature about this station is its hospitality to any school groups who want to visit. Hear evidence about the wonders of songbird migration and about birds that keep getting caught in the same nets. Join us on March 20 for a fascinating program.

February Field Trip Report Dick Smith, Field Trip Chair

The Orlando Wetlands Park is always a great place to bird, and Saturday, February 22, 2003, was no exception. We drove all the way around the Park and covered the entire North section. Although the wind was a little strong at times (this does not help when trying for the little warblers and other song birds), it was a godsend by keeping the temperature and humidity down and making it a very enjoyable day.

23 OAS members and our guests observed 68 species of birds and lots of alligators. Some of the more notable birds seen were American Bittern, Black-crowned Night Heron, Wood Stork, Bald Eagle, Purple Gallinule, Limpkin, Common Snipe, Belted Kingfisher, Purple Martin and five (5) species of warblers.

All in all, it was a great day to be in the great outdoors with good birding friends.

March Field Trip - Tosohatchee State Reserve

On Saturday, March 22, 2003, our field trip will be at Tosohatchee State Reserve in Christmas. This is a huge piece of property (34,000 acres) that offers a variety of birding habits. We will probably walk a 2 or 3-mile route at a very leisurely pace and return to the entrance about noon for a picnic lunch.

We will meet in the rear parking lot of the Burger King at E. Colonial Dr. (SR 50) and Alafaya Trail in time to sign in, get organized and leave at 7:30 a.m. Bring binoculars, field guides, water and your lunch. Just a reminder; it has been a cool winter and mosquitoes have not been a problem, but, with the temperatures rising, they are something to keep in mind. Bring your insect repellant!!

Happy Spring! Well, it feels and looks like it. Things are greening up and it won't be long before lots of time will need to be spent on the landscape. Before that happens, check the rare bird alert list (http:// groups.yahoo.com/group/FLRBA/) to see if the Eurasian Kestrel, first seen on February 26th in the Lake Apopka North Shore Restoration Area, is still hanging around and make some time to visit and see it. St. Johns River Water Management District staff unlocked the gate on Lust Road (just off Binion Road) at 8:30am on Friday, Saturday and Sunday to allow visitors to go in to view the kestrel. There were about 100 people there Saturday and again on Sunday. On Sunday when Bob and I went, we saw license plates from as far away as Pennsylvania (via Venice, FL), Virginia (finishing a vacation down here, but staying around to see the kestrel), South Carolina and all over Florida (Broward Co.,

St. Pete and Tampa, Alachua Co., Volusia Co., etc). This is just one instance of how significant this Lake Apopka North Shore is as an Important Birding Area (IBA). What a boon to the economy if we can build on this and encourage birders to visit our area for extended stays. If you are as excited as we are about this, please call or contact Bob Stamps (407/886-2925; bob_stamps@att.net), Lake Apopka Nature Education Center Chair or me (407/886-2925; LNS-OAS@att.net) to volunteer to help with this committee. Thanks.

Other ways to get outdoors and enjoy it are to sign up for the three-hour, April 19th beginning birding class offered at Orlando Wetlands Park by Susan Moss or try the more extensive beginning birding class held four Saturday mornings (last 2 in March, first two in April) taught by Tom Williams. If butter-

flies are more to your liking, sign up for the Leu Gardens class taught by Randy Snyder and Mary Keim (part of the fee will be donated to Orange Audubon). Remember to take your cameras with you and try for that winning photo contest entry (see related article in this issue).

For something that needs no real training, volunteer for our t-shirt/kids' art events (two related articles in this issue!). And, there is never a slow down in conservation issues, so keep a watchful eye and ear and let us know about them. If you have a little more time to dedicate to the cause, see the article in this issue regarding Board of Director nominations. We can use your help — either on or off the board. Conservation News Peggy Cox, Chair

"Blueways and Greenways" a presentation by Roger VanGhent, Conservation Chair of St. Johns Audubon and regional representative to the Audubon of Florida Board will be the next OAS Conservation Committee meeting on Monday, March 10th. The meeting will be at Leu Gardens, the Rose Room, starting at 6:30pm. Please come and join us to learn about these preservation techniques for environmentally sensitive lands and water resources.

Orange Audubon is opposing the City of Apopka's proposed annexation of 941 acres from Rock Springs Road to the Lake County line, including 500 acres inside the Wekiya River Protection Area. These 941

acres represent all the parcels of land recommended for acquisition as conservation lands by the Wekiva River Basin Task Force in their final report on the Western Beltway design and alignment. The proposed annexation also would rezone the mainly rural lands for higher density development, eliminate the recommended green space buffers and land use recommendations of the Task Force. These lands are currently in Orange County, who has given tentative support to the Task Force recommendations for the Beltway and land use designations in northwest Orange County. The blatant move by the land owners of these parcels and the City of Apopka threaten to undo the excellent plan for the Beltway and lands in the Wekiva basin put forth by the Task Force recommendations. OAS will state our letter of opposition at the public hearing scheduled for March 5th, 1:30pm in Apopka.

In other transportation news, the Orange County Mobility 2020 plan will be presented at neighborhood public hearing in each county district during April. These meetings will provide opportunity for public input and questions. The exact schedule will be published in a few weeks. OAS has asked county commissioners, with favorable responses, to eliminate new roads from the project list that would impact the Econ River and increase development in east Orange county (to the east of the Econ) outside the Urban Service Boundary. OAS members will be following the Mobility 2020 progress, and

be attending some of the public hearing on the initiative.

Scrub-Jay survey in Lake county will begin this month. Several OAS members have volunteered to be survey participants. Orange Audubon Recognizes Outstanding Young Scientists

Two local students were named as this year's recipients of OAS' Special Award for the 2003 Orange County Regional Engineering and Science Fair (OCRESF).

"Pesticides from our Backyard", by **Adam Tazi** was chosen as the most outstanding project in the junior category. Adam investigated the use natural pesticides. His research was very extensive but in summary, he found that as little as a 3% concentration of mistletoe extract (made from unripened berries) was an effective pesticide against

mosquito larvae. Adam is in the 7th grade at the St. Andrews School in southwest Orlando. His project also won a Butler Chain Conservation Association award.

Marissa Styne, a junior at Lake Highland Prep was chosen as the recipient for the most outstanding project in the senior category. Her project, "Does Storm Water Increase the Growth of Potentially Toxic Cyanobacteria in Florida Lakes?" examined 4 different lakes over a period of 5 months. Her results proved that the increase in nu-

trients brought into the lakes by stormwater did increase the amount of cyanobacteria in those lakes. Melissa's project also won second place overall at the OCRESF, as well as an Orange County Soil and Water Conservation award, the Stockholm Junior Water Prize, a Butler Chain Conservation Association award, and an Awesome Guide - AP Environmental Science award.

Congratulations to these promising young scientists for excellent research and presentations!
