#### Conservation News Peggy Cox, Chair

Updates: •The Lake Butler Water Quality Ad Hoc Committee heard the report of Dr. Lawrence Battoe, of St. Johns River Water Management District at their September 15th meeting. Dr. Battoe's report determined that the decline of water quality in Lake Butler was due to several events, starting with the drought of 1999-2003, then the sudden rise of water levels from record amounts of rain in 2003 washing several year's worth of sediment into the Lake. Other factors included increased runoff through 2 stormwater outlets to the Lake, due to increased development feeding the stormwater systems. While the cove restoration project that included dredging the cove contributed increased phosphorus to the Lake, it was not the leading cause of the water quality decline. The committee will meet on October 13th for peer review reports of Dr. Battoe's report, and to discuss a possible future management plan for Lake Butler. • The proposed Econ River Educational Center feasibility and site study, and planning and design were included in

the new Orange County budget. OAS expects to be part of a review of possible Center sites in October. . Land Acquisition efforts continue in Lake and Orange counties. In Orange County, the Board of County Commissioners approved a \$20 million bonding program to cement an environmental land acquisition program for the County. We look forward to helping structure a advisory type committee to implement the program with County staff. In Lake county, the public polling done by Trust for Public Lands and Nature Conservancy was just completed and we are awaiting the results. They need to show at least 35% support for a public land acquisition program for continuation with a ballot referendum for an ad valorem tax for the program. The County has appointed an excellent 9 member Public Lands Acquisition and Advisory Committee that will begin work when the ballot referendum is passed. We expect the referendum to be on the primary ballot next spring.

A Very Important Issue is being discussed in the coming months by the St. Johns River Water Management District. They have released their draft 2003 Water Supply Assessment for public comment. This assessment projects water use and the resulting impacts to water resources and natural systems through the year 2025. Water supply assessments are used to determine whether existing and reasonably anticipated sources of water and conservation efforts are adequate to supply water for all existing and anticipated future needs, and to sustain the water resources and related natural systems. These assessments are required every 5 years. The 1995 water data is the base year for this assessment and will continue to be the base year in future assessments. The goals are to project water use through the year 2025 and define the limits of water resource impacts; and to compare the projected water resource impacts with water resource constraints to identify Priority Water Resource Caution Areas (PWRCA). Most of Orange, Seminole and Lake counties are already identified as PWRCAs from the 1998 Water Supply Assessment. A public workshop will be held Friday, October 17th from 1:00-3:00pm at the SJRWMD Headquarters, 4049 Reid Street, State Hwy 100, Palatka, Florida. ## Lake Apopka -- Good News!!

A proposed agreement with the U.S. Department of Justice has been added to the agenda for the St. Johns River Water Management District Governing Board meeting in Palatka on October 7, 2003. This agreement will resolve all the legal issues pertaining to the District resulting from the bird die off in the late 1990s. For details about this, visit www.sjrwmd.com and go to "What's New". Once this memorandum of understanding has been approved by the SJRWMD Governing Board, the Lake Apopka restoration project should be able to move forward.

### First Hawk ID Field Trip

The 1st Hawk ID Field Trip will be held on Saturday, November 15, 2003 on St. Johns River Water Management District property at the Lake Apopka North Shore Restoration Area in Zellwood. Bob Sanders will be the Field Trip Leader, assisted by Bob Wheeler of OAS and Jim Peterson of SJRWMD. The plan is to car pool and drive to a location on the property where a stationary observation post will be established. The field trip will be for approximately 3 hours.

Meet at the old Bass Sod Farm gate, located 1.1 miles west of U.S. Hwy 441 on Jones Ave., at 9:00 AM. The extra vehicles will be left inside the locked gate and the group will car pool to the selected location. Car-pooling is absolutely necessary on this property, so if you have an SUV, truck or other high clearance vehicle, it would be good to bring it. Bring binoculars, spotting scopes, field guides, folding chairs or stools, water and your enthusiasm for raptors, and please be on time.
