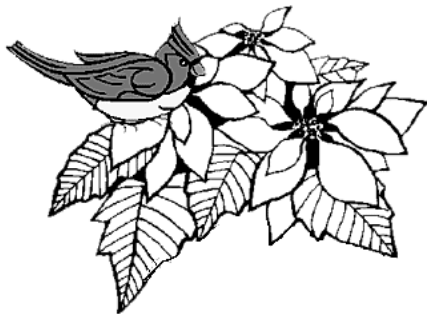
## This Month's Program: December 18, 2003 - 7:00pm Brazil's Pantanal by Bill Partington

The Pantanal region of Brazil, Bolivia, and Paraguay is the world's largest freshwater wetland, 15 times bigger than our Everglades. Last year local naturalist Bill Partington visited the Pantanal as an Earthwatch volunteer. He and other volunteers researched prey items taken by jaguars, among these giant river otters, peccaries, capybaras, rheas, and caimans. Hyacinth macaws (the world's largest parrot) and jabiru storks were among the other animals Bill was able to see in the same area. With excellent slides and his usual entertaining presentation style, Bill will describe the research project, the animals, and measures proposed to protect this unique area. Join us December 18 for a fascinating program.

## Conservation News PEGGY COX, CHAIR

The Orange Audubon sponsored Outstanding Florida Waters workshop held on November 6th was well attended, with 27 people from several city and county governments, as well as DEP and OAS, learning about the details of the OFW designation. The Environmental Regulatory Commission must make 2 findings to designate a water body an OFW: The water body must have either exceptional recreational or ecological significance, and the environmental, social and economic benefits must outweigh the costs. In OAS's membership area the OFWs are: The Econ Rive system, the Wekiva River, the Butler Chain of Lakes, and the Clermont

Chain of Lakes. The St. Johns River Water Management District have rules that require that discharging into an OFW requires 150% of the regular rules for retention and stormwater treatment. Stormwater treatment must include provisions that protect the upland riparian habitat of an OFW designated water body. Eric Shaw of DEP and Bill Carlie of St. Johns Water Management District did an excellent presentation for our group.

Directly related to an OFW, is a proposed Orange County Comp Plan amendment to change the land use on property directly connected to the Econ River in the Waterford Lakes area. Orange County's Land Planning Agency voted to recommend denial of this proposal that would require filling 17 acres of Class 1 wetlands hydrologically connected to the Big Econ River. The 34 acre site is being purchased for the construction of a super Walmart, at East SR 50 and Avalon Park Blvd. The County Commission is voting on this proposal on December 9th. OAS Board voted to send a letter of opposition to this proposal and will speak against approval on December 9th. Even with proposed mitigation for the filling of the 17 acres of Class 1 wetlands, this proposal could set a precedent for future requests to fill even more valuable wetlands that we find unacceptable. If you can, please let your County Commissioner know this is an unacceptable plan, that does not provide a public benefit that would justify destroy-

ing more of our valuable Class 1 wetlands.

Good News - The restoration plans at Lake Apopka are moving forward again with the signing of the Memorandum of Understanding with the Dept. of Justice over the pesticide poisonings of 1998-1999. The first phase of the marsh flow-way has begun that will help remove more phosphorus from the lake water. The 700 acres that has been shallow flooded on the Duda Farms east tract is now being increased by up to 1,000 more acres. The revegetation of these acres has helped provide more bird habitat in that area. Rare birds continue to be sighted on the North Shore, including 3 Grove-billed Ani, sighted on November 13th.

The Audubon of Florida Assembly, held in October, passed several new conservation resolutions that we support. These include resolutions on Land Acquisition, The Green Swamp, The Least Tern, Citizen Science, and Coastal Resources Protection. Several resolutions were revised that continue to be worked on by AOF and chapters include; Climate Change, Everglades Ecosystem, and Fire Management. Orange Audubon has previously specifically worked on issues involving Land Acquisition, Transportation (includes the Wekiva and toll roads issue), Ocklawaha River Restoration, Florida Water Resources, Growth Management. 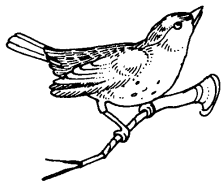
## Christmas Bird Count

The National Audubon Society calls upon volunteers everywhere to join with birders across the western hemisphere and participate in Audubon's longest-running winter-time tradition, the annual Christmas Bird Count (CBC). This year, nearly 2,000 individual counts are scheduled to take place throughout the Americas from December 14, 2003 to January 5, 2004.

This year, Audubon scientists are highlighting the fact that many of the birds to be counted are produced in the great North American boreal forest, which extends from Alaska to Eastern Canada. Boreal species traditionally seen on the CBC that appear to be declining include Belted Kingfisher, Northern Flicker, White-throated Sparrow, White-crowned Sparrow, Purple Finch, Pine Siskin, and especially Rusty Blackbird.

The data, 100% volunteer generated, have become a crucial part of the U.S. Government's natural history monitoring database. Articles published in the 103rd CBC issue of *American Birds* helped ornithologists better understand the effects of West Nile virus on regional bird populations.
