This Month's Program: January 15, 2004 - 7:00pm Simple Gifts: Our Nation's Forests, by George Sibley

Filmmaker George Sibley, through his company Gale Force Films based in Daytona Beach, has developed a series of films on environmental subjects. Conservation News Peggy Cox, Chair

Not too much new this month - and the big issues that we are part of, like the Wekiva and the SR 429 extension have been prominently featured in the media. A brief recap:

Wekiva Coordinating Committee recommended just this week for legislative help for the State to purchase 4 parcels of land considered the most important in protecting the recharge and springshed. The Lake County Commission withdrew their support for the OOCEA to continue feasibility studies of extending the 429 into Lake County. This is was tied to support for the Wekiva Parkway and a connector road from it to the Sorrento-Plymouth area on SR46. About 2 years ago the Lake Commission withdrew from their interlocal agreement with OOCEA on this road, but subsequently entered into

a new agreement that they termintated on Tuesday, December 16, 2003.

The Orange County Comp Plan Land Use Amendment that would have changed the use on 33 acres in the Avalon area for the construction of a super WalMart was withdrawn from the County Commission Agenda. The Orange County Planning and Zoning commission had recommended denial of this petition and there had been much public opposition (including OAS) to the proposal. This was the one that would have required filling 16+acres of Class 1 wetlands, connected to the Big Econ river. There was proposed mitigation that was not comparable and the precedent that would have been set by this action would have serious implications for future requests.

In Lake County, a development order approved by the County September 23rd, that would have allowed higher density development in the Green Swamp Area of Critical State Concern near Clermont, has been appealed by the Department of Community Affairs. DCA has petitioned for an administrative hearing under Chap 120., and is asking for recension of this development order. This development, a PUD rezoning (applicant Robert Shakar), has been officially opposed by OAS in the last year. It has changed considerably and the final proposal that was approved set a precedent for rezoning in the GSACSC under the County's approval that was not in complicance with the Comp Plan policies now in place. We are pleased about the DCA appeal, and local residents and others will be joining the appeal as intevenors.

The UCF master plan challenge hearings with DCA have finished, and a report should be coming out in January from DCA with recommendations. I know everyone received some of the emails reminding of the deadline on December 12th for public comment on the plan. We responded and I'm sure most of you sent in comments in support of preservation of the arboreteum and the NW conservation area.

OAS members Marge Holt and Nancy Prine were asked to serve on the new ad hoc GreenPlace land acquisition committee by Orange County EPD. Neither are serving as official representatives of OAS. I don't know exactly what criteria the county has used to select the members of the committee, but there are several environmental organizations represented through the people selected. This committee is supposed to come up with a criteria system for lands that can be purchased with the Greenplace funds. It is not the beginning of a permanent land acquisition program. It is my understanding that once the funds now available through the new \$20 million bond issue and partnerships with other agencies are gone that's it. Hopefully we can influence this to try and become a permanently funded program - maybe starting smaller than they envision at this time. The next meeting is February 18th, 1pm I think, at the County Administration Bldg. As the meetings are open to the public, I will get the exact time and place to send out in January.

OAS has not yet committed to participating in the Horticultural Display area of the Central Florida Fair (Feb. 26 through Mar. 7) because of lack of volunteers to help at the event. This would be an informational display mostly since it conflicts with the OWP event that we co-sponsor on the first weekend (see above). However, if you are interested in helping, please contact me as soon as possible (see first paragraph for contact information); this could be a good event for recruiting new members for OAS.

Spring Migration Field Trip to Fort DeSoto

Once again, this year we will sponsor an overnight field trip to Ft. DeSoto Park in St. Petersburg. The field trip will be on Saturday, April 24, 2004. The plan is to provide your own transportation there the day before, Friday, and spend that night, April 23, at the Continuing Education Conference Center at Eckerd College. This allows us to get an early start on Saturday. The cost is \$70.00 per room, two people per room. Also, the college will be providing a complete breakfast for only \$5.00 per person.

As most of you know, this is one of the premier birding spots in the entire country during spring migration. For some of us, this is our only opportunity to see many of the northern breeding species, and to get to see them in full breeding plumage is a real treat. In 2003, this was undoubtedly one of our best field trips. We had a total of 82 species and, then, we missed quite a few. If you have





not been to Ft. DeSoto Park in the spring, you owe it to yourself to bird this magnificent location.

From the December thru March meetings, we will have a sign-up sheet available in the front lobby. Payment is due on April 1, 2003. Cancellation, with a full refund, is Monday, April 19, 2004.

1st "Return to Roost" Field Trip

This will be a new approach for Orange Audubon Society, an evening field trip. On Saturday, January 24, 2004, we will travel to Orlando Wetlands Park, Christmas, in east Orange County to watch thousand of birds returning to roost for the night. After foraging all day along the St. Johns River, and other locations, waders and other birds swarm back to the OWP to spend the night. It can be a spectacular sight. With a beautiful sunset in the background, watching thousands of birds flying in from all directions to find a safe place to rest, can take your breath away. This is strictly a driving field trip. We have been given permission to take vehicle on the berms of OWP and our plan is to drive back to a predetermined location with our folding chairs, and wait for the birds to arrive. Bob Wheeler, who is intimately familiar with the Wetland Park and has led many other birding groups on similar types of trips, will be our field trip leader.

Meet in the rear parking lot of the Burger King at Hwy 50 (Colonial Dr.) and Alafaya Trail in east Orange County at 3:00PM. Bring binoculars, field guides, any refreshments that you desire, folding chairs and join us for a new kind of field trip. Remember that it can get quite chilly when the sun goes down in January- even in sunny Florida.

Have Fun with the 2004 Great Backyard Bird Count!

As in years past, Audubon, in conjunction with the Cornell Lab or Ornithology (CLO), wants to take a snapshot of North American bird populations and YOU can help them during the Great Backyard Bird Count (GBBC) on February 13-16, 2004. Everyone's contribution is important. It doesn't matter whether you identify, count, and report the 5 species coming to your backyard feeder or the 75 species you see during a day's outing to a wildlife refuge.

All you need is basic knowledge of bird

identification and access to the Internet at home, a friend's house, local library, school, or anywhere you can get access to the web. Count the birds in your backyard, local park, or other natural area on one or all four count days. Then simply go to the GBBC web site (www.birdsource.org/gbbc) and enter your data. That's all there is to it!

You can do it at your leisure so it can be a fun family activity that even the kids can participate in. And the more people who participate in this project, the more data will

be able to be collected to help researchers help our feathered friends, so join us won't you?
